

ADAVB Convention social media competition

Terms & conditions

1. The competition runs from **9am Friday 19 August to 11.59pm Sunday 21 August 2022**.
2. The competition requires entrants to post about the 2022 ADAVB Convention & Exhibition and tag the ADAVB social media accounts (Facebook, LinkedIn or Instagram) and to use the convention hashtag.
3. Only eligible entrants are in the running to win.
4. An eligible entrant is a current (2022/23) ADAVB member that has also completed the competition entry requirements.
