Member classification	Membership discounts
Student membership	Free membership for all students including ADC Candidates. PLUS free Guild Insurance.
New graduate first 6 months	Upon graduation, up to six months of free ADAVB membership and up to 18 months free Guild Insurance.
1st year graduate	Receive 67% off the full rate and pay less than \$2 per day.
2nd year graduate	Receive 34% off the full rate and pay less than \$4 per day.
Post-graduate student	Free membership for full-time post-graduate student dentists working fewer than eight hours per week. Discounted rates for post-graduate student dentists working more than eight hours per week.
3rd year graduate onwards	<b>Full rate applies from 1 July in your third year of practice. E.g. for 2024 graduates, the full membership rate applies from 1 July 2027.</b>
Public sector	<b>Have your fees reimbursed by your employer!</b> The new public sector EBA recently negotiated by the ADAVB includes a \$2000 annual allowance for reimbursement of association fees and CPD costs (pro rata for part time staff and not available for casual staff).
